January 10, 1950 - March 19, 2026

Stevan Alvin Currier, age 76, of Harriman, Tennessee, went home to be with his Lord and Savior on March 19, 2026, with his loving sweetheart of 57 years and his daughters by his side.

Born on January 10, 1950, in Harriman, Tennessee, he was the son of Onnie and Una Currier. He proudly served his country in the United States Army as an infantryman. He was stationed in Germany and served in the Vietnam War from 1969–1971 with the 1st Battalion, 7th Cavalry. His military service reflected his deep sense of duty, strength, and commitment to others. He was honored with the National Defense Service Medal and the Bronze Star.

Following his military service, Stevan attended Knoxville Business College and worked with East Tennessee Trucks, Covington Detroit/Diesel Allison, and Crete Industries. He touched many lives through his dedicated service to his church, serving as a Sunday school teacher and church treasurer for 25 years at Harriman Baptist Tabernacle, where he was a faithful member for 57 years.

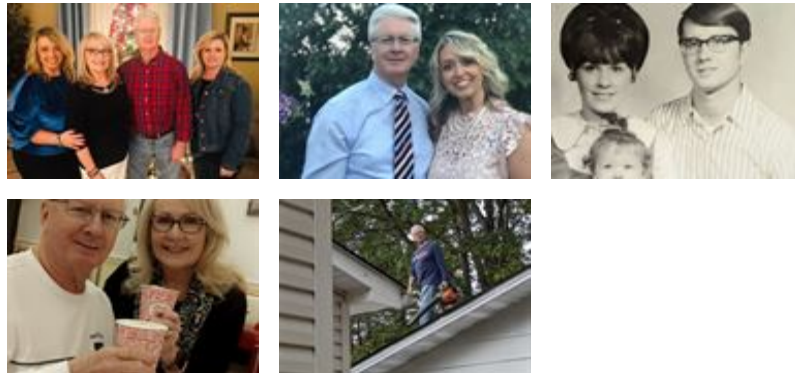
